- 1. To assist for designing and development the Request for Proposal (RFP) for appointment of Insurance company for implementation of integrated Mahatma Jyotirao Phule Jan Arogya Yojana (MJPJAY) and Ayushman Bharat- Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) across the Maharashtra.
- 2. Prepare parameters for Insurance premium calculation and estimate base risk premium rate per family per year for beneficiary families under integrated MJPJAY and AB-PMJAY.
- 3. Provide actuarial inputs and technical support during tender process including pre-bid meeting, in evaluation of bids received and in selection of new insurer.
- 4. Participate in committee meetings as well as negotiation meetings held for the purpose of selecting Insurance Company.
- 5. Prepare SoPs/Modules using actuarial and health insurance guidelines for effective implementation of integrated MJPJAY and AB-PMJAY
- 6. Support on analysis of claims data, addition and deletion of procedures, costing of procedures

7. Prepare Control mechanism to prevent fraud or grievances and guidelines for the same
